ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS FOR WORKING IN EXTRA DIVISIONAL RAILWAY HOSPITAL NORTHERN RAILWAY/ JAGADHRI WORKSHOP.

Sub:-	Walk in interview for engagement of General Duty Medical Practitioners on contract Basis for working in Extra Divisional Railway Hospital Northern Railway Jagadhri Workshop, on full time basis

A walk –in interview, for engagement of General Duty Medical Practitioners, to work on contract basis in Extra Divisional Railway Hospital Northern Railway Jagadhri Workshop will be organized for filling up vacancies. The period of contract will be for one year. Period of contract is not extendable on any grounds. However, the Railway administration shall reserve the right to enter into fresh contract with Practitioner for another term. It is not binding up on the Railway to extend the term of contract and contract can be terminated at any time without assigning any reason to the Contract Medical Practitioners. Number of maximum contract period can be 12 terms on the year basis or till attaining the age of 60 years. There will not be extension of the term beyond 12 terms/60yrs of age and such CMP will not be allowed to participate in walk in interview if the CMP completes the 12 terms/60 yrs of age, unless any amendment is issued by the Railway Board.

Retired IRMS medical officers or retired medical officers of state Gov. or Central Govt. can be engaged for five contract period of one year each, up to 65 year of age and are also invited for walk in interview. The period of contract will be for one year. Period of contract is not extendable on any grounds. However, the Railway administration shall reserve the right to enter into fresh contract with Practitioner for another term. It is not binding up on the Railway to extend the term of contract and contract can be terminated at any time without assigning any reason to the Contract Medical Practitioners There will not be extension beyond five terms/65yrs of age and CMP will not be allowed to participate in walk in interview if the CMP completes five terms/65 yrs of age, unless any amendment is issued by the Railway Board.

HVS currently on the panel of Railway are not eligible to participate in the walk in interview.

Eligible candidates are invited on the date, time and venue given below .The candidates should come prepared to stay for one day, if required, at their own expenses. No travelling allowance will be admissible to the candidates.

- The daily rate of deduction of remuneration for absence in excess of eligibility will be as per extant Railway Board policy with time to time amendment.

Note: Retired IRMS medical officers or retired medical officers of state Government and Central Government engaged as CMP will be paid fixed remuneration of Rs 46000/-per month subject to the condition that pay plus pension should not be more than last pay drawn with the same terms and conditions as per Board Letter no.2008/E(GR)II/1/1 dated 16.07.2012 and letter no.2013-E(GR)11/1/15 dated 20.05.14.

06 NATURE OF ENGAGEMENT

- (e) The engagement is purely on contractual basis for one year or till regular UPSC selected Doctors (ADMO/DMO/Sr.DMO/ACMS) become available whichever is earlier. Further the service of these doctors are also terminable before the expiry of one year. The service rendered as contract doctor is a stop gap arrangement and will not have any bearing in respect of consideration of the period in case of regular selection of these contract doctors through UPSC. It will also not confer any right for automatic regularization/absorption in any circumstance. The full time CMP who enters into contract with the railways will not have any claim or right for his /her continuity in service or automatic extension of the term of contract.
- (f) The CMP shall undergo a medical examination, before the contract is entered into, for his/her to perform the work awarded to him/her.
- (g) All other terms and conditions as laid in Railway Board's Letter No. 96/E/(GR)ii dated 23.02.2000 and as mentioned from time to time shall be binding up on the CMP's.
- (h) After selection of the two (02) CMP's the names of the remaining candidates who appeared in the walk-in interview will be kept on waiting list and in the event of any vacancy arises in future will be filled by these candidates.

07 OTHER FACILITIES

- 08** One set of 1st class complimentary pass for self & family during each contract will be issued after three months of regular contract service as per Railway Board Extant rule applicable to CMP(except retired Railway Doctor).

- 09** Full time CMP's may be provided unfurnished accommodation subject to availability. In case Railway accommodation is provided to the CMP, an amount equivalent to the sum of HRA and license fee of accommodation so provided shall be deducted from the monthly remuneration to the CMP as per extant rule..

- 10** The CMP may avail of free medical treatment for self only except operations categorized as " Special" in Para 622(8) of Indian Railway medical Manual 2000 and treatment normally available at super speciality centre from his/her respective zonal railway hospitals during the currency of contract.

11 QUALIFICATION

MBBS from a recognized University and must have completed compulsory otator internship for one year and should be in possession of a valid Registration Certificate from any of the State Medical Council of India or MCI.

AGE

i-Not exceeding 48 yrs. As on 01.10.2020 subject to maximum twelve terms of one year each or till the age of 60 yrs whichever is earlier.

ii- Not exceeding 61 years on 01.10.2020 for retired IRMS Officers/ retired Medical Officers of State Govt. and Central Govt. subject to maximum five terms of one year each or till the age of 65 yrs whichever is earlier

iii- Age relaxation for SC/ST- 5yrs and for OBC- 3yrs


iv- Candidates who fulfill above terms and conditions and having requisite qualification should be present on the scheduled date, time and venue with their original certificates (and one self attested photo copy of each certificate) , proof of date of birth, educational qualification (degree & marksheets), certificate of compulsory rotator internship, experience (if any), caste (in case of candidates belonging to reserved community) registration with Medical Council of India/State Medical Council of India and 06 Nos of passport size photographs, along with ID Proof.

12 TERMINATION OF CONTRACT:

During the period of contract either party (the Contract medical petitioner or Railway Administration) is free to terminate the contract on 15 days prior notice. In Case the Contract medical petitioner is found physically or mentally invalid or incapacitated the contract can be terminated forthwith. However if CMP leaves without notice or before completion of 15 days notice, he/she shall be liable to pay the amount for the required period as per prevailing rates.
